Residential Program - Clients in this program have a bed for a determined period of time, depending on clients' needs/barriers upon initial assessment. At the beginning of their stay, clients take part in a comprehensive, empathetic process to address and identify the unique barriers to obtaining sustainable housing. Clients work in partnership with a case manager and develop a plan to address these barriers. To enter this program, one must commit to working on finding employment, saving income and using these savings towards obtaining sustainable housing. Everyone in this program is required to be clean and sober at entry and willing to remain sober for the duration of one's stay.

4b (Code:) (Expenses \$ 853,903 including grants of \$) (Revenue \$)

Service Center - The services-to-all program provides a wide range of services on a walk-in or appointment basis which help individuals address their own unique barriers to stable housing. Services include, employment assistance, substance abuse evaluations, mental health assessments, health care, referrals for clothing, transportation assistance, access to laundry and showers, and networking to more than 30 community organizations who partner with us to provide wider access to resources, care and expertise.

Health Clinic - The Shelter Association Health Clinic is administered in a partnership with Packard Health. The SAWC provides a medical Case manager and financial support for a Medical Director, plus pharmaceutical expenses for clients.
