The Residential Program - Provides emergency shelter and supports to homeless men and women in Washtenaw County each year. Each client partners with a SAWC case manager to create mutual goals in a housing plan. The plan focuses on overcoming housing barriers through referrals to housing resources and vouchers, benefit coordination, and community supports. Each year, the Shelter Association aims to improve landlord engagement and advocate for more affordable housing in Washtenaw County. The SAWC has a goal of assisting at least 60% of Residential guests to locate affordable housing each year. Clients are also provided assistance with addressing other needs including mental health conditions, physical disability, transportation assistance, substance abuse, help with finding employment,

4b (Code:) (Expenses \$ including grants of \$) (Revenue \$)

The Shelter Diversion Program - Aids up to 60 individuals at a time to locate safe, affordable housing without staying in the shelter. The program provides a SAWC case manager to assist the client with obtaining supportive networks in the community to end a person's homelessness before a Residential bed becomes available to a guest. In fiscal year 2018, 119 persons secured housing in the Shelter Diversion Program without having to stay a night in shelter. Additional basic needs services include an onsite medical clinic, laundry, storage, showers, phone and mail access. Clients are also provided assistance with addressing other needs including mental health conditions, physical disability, transportation assistance, substance abuse, help with finding employment, and accessing education

Health Clinic - Packard Health partners with the Shelter Association to provide primary medical care and a once a week psychiatric clinic for mental health evaluations and medication reviews. In the 2017 fiscal year, The SAWC/Packard Collaboration served 385 persons. This integrated care model is successful in linking a vulnerable, priority population to vital medical and mental health psychiatric services. The program supports patient-centered medical care for those with reduced medical adherence and access to care. The Packard Health Clinic on the second floor of the Delonis Center serves single adult men and women age 18 and over who are experiencing homelessness. In the SAWC, over 60% of those served have an ongoing disabling condition and over 43% of those served have a severe and
